

**JUDGMENT**

The above-styled action having been called by the Court for trial on November 12, 2008, and the parties having announced ready, and thereafter fourteen jurors, including two alternate jurors, were duly sworn and impaneled to try the issues herein. Thereafter opening statements were made by counsel for the Plaintiff and the Defendants Ron Edwards and Jarred Hensley, and the trial proceeded with the Plaintiff presenting evidence, following which the case was adjourned until the following day of November 13, 2008, with the appropriate admonition by the Court.

Thereafter, on November 13, 2008, all jurors being present, the trial proceeded with the Plaintiff presenting additional evidence, following which the case was adjourned until the following day of November 14, 2008, with the appropriate admonition by the Court.

Thereafter, on November 14, 2008, all jurors being present, the trial proceeded with the Plaintiff presenting additional evidence, until the close of Plaintiff's evidence, following which a Motion for a Directed Verdict was made by the Defendant Ron

Edwards, with ruling thereon as shown in the official electronic record of proceedings herein.

Thereafter the Defendant Ron Edwards was given the opportunity to present evidence, but declined to do so, following which said Defendant announced his case closed.

Thereafter the Defendant Jarred Hensley was given the opportunity to present evidence, but declined to do so, following which said Defendant announced his case closed.

Preceding and during the course of said trial, various motions and objections were made by the parties, with rulings thereon by the Court all as shown in the official electronic record of proceedings herein.

Thereafter the Court instructed the jury in accordance with the Court's instructions, to which neither party objected, following which closing statements were made by Defendant Ron Edwards and Defendant Jarred Hensley and counsel for Plaintiff, following which the two alternate jurors were determined and released and the case was finally submitted to the jury for its verdict.

The jury retired to deliberate its verdict, and thereafter returned to open court with its verdict in favor of Plaintiff in the total amount of \$2,501,686.71, as contained in the official clerk's record herein.

Of the aforesaid total verdict, \$1,501,686.71 was in compensatory damages. The jury attributed twenty-percent (20%) of the fault to Defendant Ron Edwards. Therefore, Defendant Ron Edwards is liable for \$300,337.34 (twenty-percent (20%) of the total award for compensatory damages).

BTA

Of the aforesaid total verdict, \$1,000,000.00 was in punitive damages solely attributable to Defendant Ron Edwards.

**NOW THEREFORE, IT IS ORDERED AND ADJUDGED** as follows:

Plaintiff, Jordan Gruver, shall recover from Defendant Ron Edwards, the sum of \$1,300,337.34, which is twenty-percent (20%) of the compensatory damages award, plus \$1,000,000.00 in punitive damages. In addition, Plaintiff shall recover post-judgment interest on said \$1,300,337.34 at the rate of 12% from the date of entry of this Judgment until the Judgment is satisfied; all for which let execution issue forthwith.

**This is a final and appealable Judgment and there is no just cause for delay.**
