JUDGMENT

THIS MATTER HAVING been noticed for trial by jury and the parties being present in court and represented by counsel and a jury being duly impaneled and sworn and evidence and testimony having been presented and the jury having deliberated and having reported their verdict on the Verdict Form; wherein, they found in favor of the Plaintiffs and against the Defendants as follows:

1. Actual damage sustained by Victoria Keenan as a result of the wrongful conduct of all Defendants is: \$250,000.00.
2. Actual damage sustained by Jason Keenan as a result of the wrongful conduct of all Defendants is: \$80,000.00.
3. Punitive damages JOHN YEAGER should pay the Plaintiffs: \$100,000.00.
4. Punitive damages JESSE WARFIELD should pay the Plaintiffs: \$500,000.00.
5. Punitive damages MICHAEL TEAGUE should pay the Plaintiffs: \$600,000.00.
6. Punitive damages RICHARD BUTLER/ARYAN NATIONS/SAPPHIRE, INC. should pay the Plaintiffs: \$4,800,000.00.


for a total Judgment of \$6,330,000.00 plus interest at the statutory rate of 11.25%, which sum constitutes the amount of damages as awarded by the Jury.

IT IS HEREBY ORDERED that Judgment is entered in favor of the Plaintiffs as follows:

- A. In favor of VICTORIA KEENAN against all Defendants *(except Michael Teague)* in the amount of \$250,000.00 as actual damages, *and in the amount of \$25,000 against Michael Teague*
- B. In favor of JASON KEENAN against all Defendants *(except Michael Teague)* in the amount of \$80,000.00, *and in the amount of \$8000 against Michael Teague.*
- C. For punitive damages in favor of both Plaintiffs and against JOHN S. YEAGER in the amount of \$100,000.00. *CT*
- D. For Punitive damages in favor of both Plaintiffs against JESSE WARFIELD in the amount of \$500,000.00.
- E. For punitive damages in favor of both Plaintiffs against MICHAEL TEAGUE in the amount of \$600,000.00.
- F. For punitive damages in favor of both Plaintiffs against RICHARD BUTLER/ARYAN NATIONS/SAPPHIRE, INC. in the amount of \$4,800,000.00 together with interest at the statutory rate of 11.25%.
- G. IT IS FURTHER ORDERED that Plaintiffs may apply for costs pursuant to Rule 54(d)(1) I.R.C.P.
