J U D G M E N T

This action came on trial before the Court and a jury, Honorable Charles A. Moye, Jr., United States District Judge, presiding, and the issues having been duly tried, the jury having duly rendered its verdict, and the parties having entered into a stipulation regarding the verdict,

It is ORDERED AND ADJUDGED:

(1) that the plaintiffs are a class of persons consisting of the individuals who participated in the protest march in Forsyth County, Georgia, on January 17, 1987; however, the class does not include Hosea L. Williams, Jr., Elizabeth W. Omilami, Terrie L. Randolph, Forrest Sawyer, Jr., Arthur McDonald, Lynne Randolph, Donald P. (Ty) Robinson, or Jeff Warren;

(2) that the plaintiffs shall recover of the defendants the Southern White Knights, Knights of the Ku Klux Klan; the Invisible Empire, Knights of the Ku Klux Klan; David Holland; Edward Stephens; Daniel Carver; Gregory Allen Boyd; Marion Franklin Shirley; Joe Thomas Stewart; Tony DeWayne Rich; Earl Watts; Douglas McGinnis; Roy James Sweatman; and Thomas James Gayton, the sum of two thousand five-hundred dollars (\$2,500.00) in compensatory damages, with interest thereon at the rate of 8.04% per annum as provided by law;

(3) that the plaintiffs shall recover of the defendants listed below the following sums in punitive damages, with interest thereon at the rate of 8.04% per annum as provided by law:
