FINAL JUDGMENT

THIS MATTER having come on for trial before the Court and a jury beginning on June 3, 2015; and the case having been heard and submitted to the jury, and the jury having rendered a verdict on June 25, 2015 in favor of Michael Ferguson, Benjamin Unger, Chaim Levin, Jo Bruck, and Bella Levin (collectively "Plaintiffs") and against JONAH (Jews Offering New Alternatives for Healing f/k/a Jews Offering New Alternatives to Homosexuality), Arthur Goldberg, Alan Downing, and Alan Downing Life Coaching LLC (collectively "Defendants"); and the jury having awarded damages in the amount of \$1,050 to Michael Ferguson, \$17,950 to Benjamin Unger, \$650 to Chaim Levin, \$500 to Jo Bruck, and \$4,000 to Bella Levin; and those awards being mandatorily trebled pursuant to the New Jersey Consumer Fraud Act, N.J.S.A. 56:8-19, resulting in a final damages award of \$3,150 to Michael Ferguson, \$53,850 to Benjamin Unger, \$1,950 to Chaim Levin, \$1,500 to Jo Bruck, and \$12,000 to Bella Levin; and Plaintiffs being entitled to a mandatory award of attorneys' fees and reimbursement of expenses pursuant to N.J.S.A. 56:8-19, and Plaintiffs having expressed their intent to apply for permanent injunctive relief; and the parties having submitted a Consent Order Granting Permanent Injunctive Relief and Awarding Attorneys' Fees, and the Court having entered that Order on December 18th, 2015;

ORDERED, that final judgment be and hereby is entered for Plaintiffs, Michael Ferguson, Benjamin Unger, Chaim Levin, Jo Bruck, and Bella Levin, against all Defendants.
