On Saturday, July 25, 2015, an incident occurred on Campbellton Street here in Douglas County. That incident involved individuals associated with a group known as "Respect the Flag" who were driving around the community in vehicles displaying the Confederate flag. Those individuals stopped near a residence on Campbellton Street, where a group of local citizens were having a birthday party, and a confrontation ensued. That incident was the topic of extensive media coverage when it occurred. Since that time, the Douglasville Police Department and the Douglas County District Attorney's Office have been conducting an investigation into the circumstances surrounding that incident. On Friday, October 9, 2015, a Douglas County Grand Jury handed down an Indictment charging members of the group known as "Respect the Flag" with violations of Georgia's Street Gang Terrorism and Prevention Act and Terroristic Threats. Two members of that group were also charged with Battery for an incident that occurred that same day at a gas station in an area of Douglas County known as the Corn Crib. The cases resulting from the Indictment will be handled in the Douglas County Superior Court. There is no further comment at this time.
