# Poll Shows Mississippi Voters Strongly Support Restoring Ballot Initiative Process; Expanding Medicaid and Postpartum Benefits to Mothers 

Tulchin Research recently conducted a survey among likely voters in Mississippi (MS) on behalf of the Southern Poverty Law Center Action Fund to gauge public opinion on a variety of policy issues. Specifically, our statewide survey finds strong support among voters for the State Legislature to restore the state's ballot initiative process to allow voters to once again be able to vote directly on measures. The survey also finds broad support for expanding key healthcare services statewide, including strong majorities of voters supporting Medicaid expansion and, specifically, extending post-partum care for new moms from 60 days to one year as nearly every other state in the country has done.

We present findings from the poll below.

## Voters Support Restoring the Ballot Initiative Process in Mississippi

Nearly two-thirds of likely voters (65\%) want the Mississippi State Legislature to restore the state ballot measure process, including $40 \%$ who strongly support it. Conversely, just 14 percent of voters oppose restoring these rights to voters while one-in-five voters (21\%) have no opinion or are unsure.

## Support for Restoring Ballot Measure Process in Mississippi

## Voters Want to Expand Medicaid, Especially to Aid Rural Hospitals and New Mothers

Considering the impending closure of 38 rural hospitals across the state, a strong majority of voters agree with a statement describing how Mississippi should expand Medicaid (61\%). Conversely, a quarter of voters believe Mississippi should not expand Medicaid (25\%) and 14\% of voters are undecided.

## Strong Support for Medicaid Expansion

Additionally, there is strong support statewide (67\% total support, 49\% strongly support) for extending Medicaid coverage for mothers of newborn children from two months to a year while a little over a quarter of voters (27\%) oppose expanding this benefit.

## Support for Extending Medicaid Coverage for New Mothers

As you may know, currently in Mississippi Medicaid health care coverage for mothers of newborn children, including maternal care, ends 60 days after birth. A bill has been proposed to extend this maternal healthcare coverage to a year.
Knowing this, do you strongly support, somewhat support, somewhat oppose or strongly oppose expanding this Medicaid coverage for moms from 60 days after birth to one year?

## Conclusion

Voters in Mississippi have strong preferences for their state legislators to make progressive changes that will give power back to voters by restoring the statewide ballot measure process. Additionally, there is broad support for expanding key healthcare services statewide, including Medicaid expansion generally and expanding coverage for mothers of newborns from two months to a year, specifically.

Survey Methodology: From January 21-25, 2023, Tulchin Research conducted a survey among 500 likely voters in Mississippi. The survey was conducted by contacting voters by landline and cell phone as well as online through email and text message. The margin of error for the survey is +/- 4.3 percentage points.
