SENTENCE AND CONDITIONS OF PROBATION

As a result of your conviction, you are hereby placed on active probation for a period of 90 DAYS. The conditions and terms of probation thereof, having been fully explained, are understood by Defendant to be as follows:

INFORMATION ABOUT CONVICTIONS FOR DRIVING WHILE LICENSE IS SUSPENDED

If you were charged and convicted of Driving While License is Suspended, in addition to the penalties imposed by First Parish Court, the Department of Public Safety - Office of Motor Vehicles is authorized to impose the following:
R.S. 32:415(B)(1) - Any period of suspension or revocation shall automatically be extended for a period of one year from the date the licensee would otherwise have been entitled to apply for a new license upon his conviction for any offense involving the operation of a motor vehicle committed during such period ...

I have read and understand the above stated conditions of my probation. I also understand that failure to comply in any regard will result in the revocation of my probation and imposition of the original sentence of in the Jefferson Parish Correctional Center will be executed.

RESCHEDULING FEE

As a result of your conviction for the offense of 32:53D, you have been placed on a period of 90 DAYS active probation.

You have been sentenced to:

ENGLISH CLASSES

If, for any reason, you feel you must reschedule a community service workday, substance abuse or driver education school, the fee charged for the first reschedule will be \$30.00. Second reschedules will be charged \$40.00. One Way for the Road participants must pay \$150.00 to reschedule and can only reschedule twice.

Rescheduling will be done as follows:


- 1) The first/second time you reschedule, you must come in and pay the rescheduling fee before the rescheduling will be done. Failure to come in and pay the rescheduling fee will put you in Contempt of Court.
- 2) If you miss a day and do not come in to reschedule, an **attachment** will be issued for your arrest and you will have to appear in court before any rescheduling can be done.


**RESCHEDULES ARE ONLY DONE (IN PERSON) MONDAY-FRIDAY
BETWEEN THE HOURS OF 8:30 A.M. TO 10:30 A.M. AND 2:00 P.M. TO 3:30 P.M.**

- 3) If you need to reschedule a day you missed on the weekend, your dates will be compelled to weekdays. There will be **NO EXCEPTIONS** to this rule regardless of what your work schedule is at your job.
- 4) If an attachment is issued for your arrest for any of the above mentioned programs a \$40.00 rescheduling fee will automatically be imposed upon you.
