IT IS HEREBY STIPULATED AND AGREED, by and between the undersigned, the attorneys of record for the parties herein, pursuant to Fed. R. Civ. P. 41(a)(1)(ii), that: (1) the above-captioned action be dismissed, without prejudice and without costs, including attorneys' fees, to either party as against the other; (2) the parties will attempt to resolve their disputes through private mediation within ninety (90) days of the date of this Stipulation; (3) if mediation is unsuccessful, to the extent permitted by law Plaintiffs may refile this action without prejudice; and (4) the statutes of limitations on each of Plaintiffs' alleged causes of action are tolled for a period of one hundred and twenty (120) days from entry of this Order to allow for mediation.

This Stipulation may be filed without further notice with the Clerk of the Court.
