On 03/13/2018 at approximately 01:17am I, Officer Rachael Rodriguez with the Paoli Police Department was notified to be en route to Walmart, [REDACTED] Paoli IN 47454 in reference to a male that had be assaulted by his wife and his wife's boyfriend.

When I arrived at Walmart I spoke with David Matthew Parrott [REDACTED] Parrott advised me that he had been assaulted by his wife Jessica Parrott [REDACTED] and her boyfriend later identified as Matthew Heimbach [REDACTED]. David Parrott went on to state that his step-daughter [REDACTED] was in immediate danger because she had a recording of his wife and his wife's boyfriend.

I then left Walmart and proceeded to [REDACTED] Paoli IN 47454 to make contact with [REDACTED]. When I arrived I was met by Matthew Heimbach, a third uninvolved party, and Jessica Parrott. Jessica Parrott at this time stated that she was just a neighbor and wanted to go home so I advised her to leave. Matthew Heimbach said [REDACTED] was inside with the children. [REDACTED] came to the door and advised me that she was putting her children down for bed. [REDACTED] seemed to be upset and nervous. I told [REDACTED] to lay them down and come back out to speak with me.

After waiting a few minutes Matthew Heimbach went inside to put the children down and send [REDACTED] out to speak with me instead. During this I overheard Matthew Heimbach tell [REDACTED] to send the police away

and tell them everything was fine. Matthew began to raise his voice at her and I heard scuffling and [REDACTED] yelling.

At this time I entered the residence and ordered Matthew to come out of the bedroom. I placed him and handcuffs escorted him to my patrol vehicle. [REDACTED] was visibly upset and crying while holding one of her children. It should be noted that both children were present in the room during this time, [REDACTED]. [REDACTED] stated that Matthew had grabbed her by the cheeks and pushed in. Her cheeks were red around the mouth area.

[REDACTED] advised me that Matthew Heimbach had been having an affair with Jessica Parrott and that she and David Parrott had learned this last week. Both Jessica and Matthew had stated that they were done seeing each other after a 3 month affair. After this [REDACTED] and Jessica made a plan to "set up" Matthew Heimbach to see if Matthew would in fact attempt to sleep with Jessica after they had stated that they had ended things.

During this set up which occurred at [REDACTED] [REDACTED] and David were outside watching. [REDACTED] got scared and ran away and David stayed behind watching the encounter on a box through a window. While doing this the box broke and his ran around the trailer to confront Matthew. Stating get off my property. Matthew wouldn't leave so David then stated get off my property again and poked Matthew in the chest. From this David stated that Matthew grabbed his hand and twisted down then got behind him and "choked him out" with his arm. David stated that he lost consciousness briefly

and that when he came to Jessica was standing over him. He than ran out of the trailer to the house [REDACTED] Paoli IN, 47454). Once in the house Matthew came in and David again told Matthew to leave. When he didn't David threw a chair at Matthew to make him leave and Matthew proceeded to then choke him again in the same manner as before. David went unconsciousness again. When he woke he overheard Jessica telling Matthew that that they needed to find [REDACTED] because she has the recording on her phone.

It should be noted that David did have visible marks on his throat and his stated that his hand hurt when he attempted to complete his paperwork. As a result I transcribed the paperwork for him.

At this time, David ran to the Walmart with his child, [REDACTED] [REDACTED] in his arms.

Jessica Parrott agreed to have [REDACTED] stay at David's mothers on [REDACTED] for the night. Due to safety concerns for [REDACTED] they also left with David and stayed at the house on [REDACTED] for the night.

Both [REDACTED] and David Parrott completed voluntary statements and battery affidavits reference the events.

Matthew Heimbach was transported to Orange County Jail.
