Dear Mr. Torres:

Our office handles public records requests for Sheriff Greg Champagne as Custodian of Records for the St. Charles Parish Sheriff's Office. We have been provided a copy of your letter dated December 20, 2018 that was received by Captain Maurice Bostick on January 2, 2019.

With respect to your request, under Louisiana law, the Custodian of Records may not release any information which is privileged, confidential or otherwise protected from disclosure by Louisiana or federal law. This would include, without limitation, the release of information which would constitute a violation of an individual's right to privacy as mandated by La. Const. Art. 1.§ 5. (La. Const. 1974), such as certain personal information including, but not limited to, home addresses, personal telephone numbers, next of kin, social security numbers.

The Custodian of Records will perform a good faith and diligent search in an effort to identify the existence and availability of public records that may be responsive to your request as written. However, "[t]he custodian of public records cannot be expected to produce records that it cannot identify." Hatcher v. Rouse, 16-0666 (La. App. 4 Cir. 2/1/17), 211 So.3d 431 citing All for Affordable Energy v. Frick, 96-1763, p. 7 (La. App. 4 Cir. 5/28/97), 695 So.2d 1126, 1132

As we appreciate your request, you seek:

Ordering Agreement (BOA) with Immigration and Customs Enforcement.

We have identified the Basic Ordering Agreement (BOA). While nothing but the BOA has been requested, out of the abundance of caution, the Custodian of Records expressly asserts and incorporates herein as if copied *in extenso* the section of the BOA regarding Public Disclosures.

Further, pursuant to La. R.S. 44:32C(1)(a), the Custodian of Records will require payment of fees for copies in advance of production. Sheriff Champagne is not a state agency and is not bound by La. R.S. 44:32(2) which requires a uniform fee schedule adopted by the commissioner of administration, as provided by R.S. 39:241. The Custodian of Records has established and published his own fee schedule which is posted on the St. Charles Parish Sheriff's website. The aforementioned Basic Ordering Agreement comprises approximately two (2) pages. Please advise if you would like copies of this document and the appropriate invoice can be generated and forwarded to you for pre-payment of two (\$2.00) dollars to the "Sheriff's General Fund-St. Charles Parish."

By providing this response to you, please be advised that the Custodian of Records has not waived any additional objection it has or may have, with respect to your request, its form, nature, demands or substance.

In the event after additional investigation, further response is required, or other action is taken in furtherance of this request, or any subsequent requests, the Custodian of Records reserves any and all rights granted by law, jurisprudence or Attorney General Opinion.

It is the policy of the Custodian of Records to undertake every reasonable effort to respond to public records requests as required by Louisiana law. However, if the information is not required to disclosed pursuant to Louisiana law or federal law, the Custodian of Records will abide by that law.
